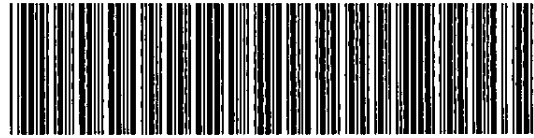



Article IV

Musicians Unlimited, Inc. will have a self-perpetuating board that provides an opportunity to bring together a group of committed people who have a chance to define and carry out the goals of the organization. The board for Musicians Unlimited will elect its own members on a yearly basis by determining its needs based on the profile of the present board. Quarterly meetings will be held in order to monitor the organization's progress and make the decisions needed for the agency to move forward. Board members can elect and re-elect their colleagues and/or others to the board positions. The board will consist of three to five board members that are familiar with the community to be served and/or have an understanding of the requirements needed to musically instruct children. The board officers will include a president (or chair), vice president (or vice chair), public relations specialist, treasurer, and a parent representative (a parent that is taking part in our program). The Board for Musicians Unlimited, Inc. will permit for a person on the board to hold multiple officer positions simultaneously, but it doesn't permit the individual to act in more than one capacity where the authority of two or more officers is required. Once appointed and on a yearly basis, board members will need to declare in writing no conflicts of interest. In the event, that a board member is determined not to have the organization's best interest at heart the board member can be removed from the board with a majority ruling reached among the rest of the board members. Board members are required to provide written notice in the event they decide to relinquish their position.
