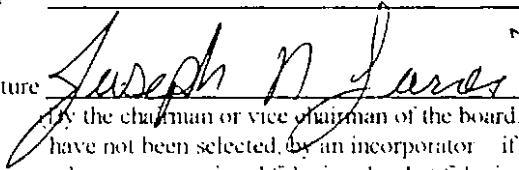

In Compliance with Chapter 617, F.S., (Not for Profit)

**ARTICLE I NAME**

**ARTICLE III PURPOSE**

This corporation is organized exclusively for charitable, religious and religious-educational purposes, including for in-kind purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code which governs non-profit corporations.

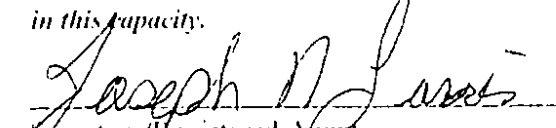

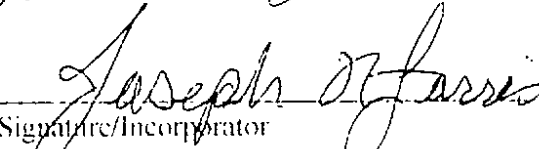
