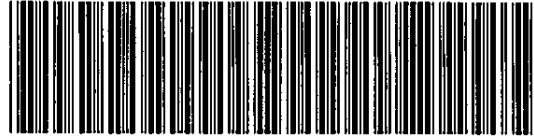

Dissolution of the organization:

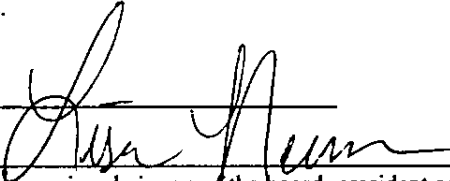
