ARTICLE I ___NAME

The Name of the corporation shall be: BELLEVIEW ENDOWMENT TRUST FUND

ARTICLE III PURPOSE

The purpose for which the corporation is organized is: to provide funds exclusively for charitable and other qualified projects supported or funded by Belleview Masonic Lodge and other local (Belleview, Florida) civic and charitable organizations to provide matching funds for specific charitable events/programs.

ARTICLE IV MEMBERS AND DIRECTORS

The corporation shall not have members, shall only have directors and the directors shall have sole voting power. There shall be seven (7) members of the Board of Directors.

ARTICLE V MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected and appointed: The Board of Directors shall be made up of seven (7) individuals, four (4) of whom shall be the Past Masters of Belleview Masonic Lodge No. 95 F&AM ("Belleview Masonic Lodge"), a Florida not for profit corporation, the setting Master and Senior Warden of Belleview Masonic Lodge, and the seventh individual to be appointed by the other six members of the Board of Directors.

ARTICLE VI ELECTION OF OFFICERS

The Board of Directors shall appoint such officers of the corporation as they deem necessary.
