Amending Article III

Oak View Middle School Band Boosters Incorporated will here in be referred to as the OVMSBB Corp. OVMSBB Corp. is organized and will be operated exclusively for charitable and educational purposes within the meaning of 501(3)(c) of the Internal Revenue code. (All references to sections in these Article will refer to the Internal Revenue code of 1986 as amended or to comparable sections of subsequent internal revenue laws.) Specifically, OVMSBB Corp. is organized to promote open communication and parent involvement with Oak View Middle School.

Adding Article IX

The internal affairs of the OVMSBB Corp. shall be regulated by its Board of Directors as described in the Bylaws. Upon dissolution of the OVMSBB Corp., its assets shall be disposed of exclusively for the purposes of the OVMSBB Corp. or distributed to such organizations organized and operated exclusively for charitable purposes. These said organizations will be, at the time of such action, exempt under section 501(c) (3), or the assets shall be distributed to the federal government, or to a state or local government for a public purpose. Any such remaining assets shall be disposed of by the appropriate court of jurisdiction of Alachua County Florida for the purposes of nonprofit concerns and organizations as the court determines appropriate.

Adding Article X

No part of the net earnings of the OVMSBB Corp. shall inure to the benefit of or be distributed to any director, employee or other individual, partnership, estate, trust, or corporation having a personal or private interest in the OVMSBB Corp. Compensation for services actually rendered and reimbursement for expenses actually incurred in attending to the affairs of OVMSBB Corp. shall be limited to reasonable amounts. No substantial amount of the activities of OVMSBB Corp. shall be the carrying on of propaganda, or otherwise attempting to influence legislation. OVMSBB Corp. shall not intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate of public office. Notwithstanding any other provision of these Articles or of any Bylaws adopted thereunder, OVMSBB Corp. shall not take any action not permitted by the laws which then apply to OVMSBB Corp.
