The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be: Indigenous Moorish-American Commission, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:
18790 US Highway 301 South, Wimauma, Florida 33598

ARTICLE III PURPOSES

The specific purpose for which the corporation is organized is: Non-profit charitable organization service provider for any and all lawful fundraising and activities in the authentication and assurance that all constituents are adhered in the protection of providential rights of the inherited Nobility of the Aboriginal / Indigenous/ Natural People's Self-Determination; as with the promotion of National and International self-esteem through various charitable initiatives that branch off to multilateral enterprises for the actuation of social welfare, education, spirituality, and prosperity programs that negate injustice, conflict, and discrimination; however, promote culture and civic participation under Moabite/Moorish/Moroccan-American Divine Principles of Love, Truth, Peace, Freedom, and Justice.

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
