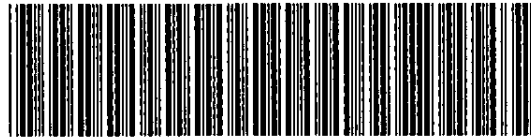

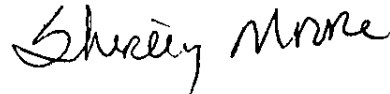

1. Name: Jacksonville Day Resource Center, Inc., ("Corporation") **EFFECTIVE DATE** 2/22/13
2. The initial street address and mailing address of Corporation is 1912 Hamilton Street, Suite 203, Jacksonville, Florida, 32205 (attn. Shirley A. Moore).
