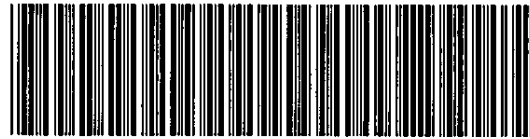

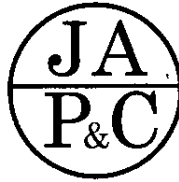

3. After the addition described in Paragraph 2, the officers of the Corporation, and their respective addresses; shall be reflected as follows:


