

Article X

(a) The property of this corporation is irrevocably dedicated for the charitable, educational, and scientific purposes and no part of the net income or assets of the oranization shall ever inure to the benefit of any director, officer or member thereof or the benefit of any private person. (b) On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of tihis corporation, shall be distrivuted to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for Religious under Section 501(c)3 of The Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a stat or local government for a public purpose. Any such asset not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such or oranization as said court shall determine which are oranized and operated exclusively for such purposes.
