ARTICLES OF INCORPORATION

MANATEE 20 CONDOMINIUM ASSOCIATION, INC.

A NONPROFIT CORPORATION

I, the undersigned a natural person of legal age, a citizen of the State of Florida, acting as incorporator of a corporation under Chapter 617 of the Florida Statutes, do hereby adopt the following articles of incorporation for such corporation:

ARTICLE I

The name of this corporation (called the association) is MANATEE 20 CONDOMINIUM ASSOCIATION, INC.

ARTICLE II

The association is a non-profit corporation.

ARTICLE III

The period of its duration is perpetual.

ARTICLE IV

The specific primary purposes for which the association is formed are to provide for implementation of the Declaration of Condominium of Manatee 20, a Condominium, and the maintenance, preservation, and architectural control of the condominium and common area within a certain tract of real property described as follows:


