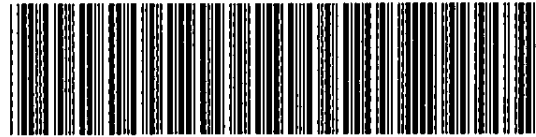

In compliance with Chapter 617, F.S. (Not for Profit)

### **ARTICLE ONE**
