Amendment to Article III:

Caduceus Recovery Foundation, Inc. (CRF) is a nonprofit organization operating exclusively for charitable purposes within

the meaning of section 501 (c)(3) of the internal revenue code. Caduceus Recovery Foundation Inc.'s purpose include, without

limitations, the promotion of educational and clinical support services for impaired or affected professionals, their families

and the strengthening of professionals' accountability. We provide education on the diagnosis and treatment of mental health

and drug addiction issues and promote awareness in the community, public and private entities; develop programs and comply with strict

protocols for licensed professionals, athletes and executives to maintain licensure and public trust; promote training, professional

understanding and public awareness of important programs in order to identify and treating mental health and substance use and abuse.

Additional Article: Private Foundation

Notwithstanding any other provisions in these articles, at all times when the corporation is a private foundation within the meaning

of section 509 of the code, is shall be subject to the following additional restrictions:

a. The corporation shall distribute the income for each tax year at such time and in such manner as not to become subject to

the tax on undistributed income imposed by Section 4942 (d) of the code.

b. The corporation shall not engage in any act of self-dealing as defined in Section 4941 (d) of the Code.

c. The corporation shall not retain and excess business holdings as defined in Section 4943 (c) of the Code.

d. The corporation shall not make any investments in such manner as to subject it to tax under Section 4944 of the Code.

e. The corporation shall not make any taxable expenditures as defined in Section 4945 (d) of the Code.

Additional Article: Dissolution

In the event Caduceus Recovery Foundation, Inc. dissolves the board of directors, employees and staff shall ensure all liabilities are

resolved. The board of directors must dissolve all exempt assets of the corporation to qualifying mental health and substance abuse charitable

501(c)(3) organizations in the community. Any assets of the corporation not distributed by the board of directors must be disbursed by Florida state courts.
