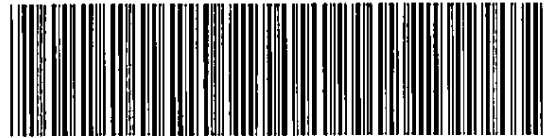

WHEREAS, the Master Declaration for Championsgate (the "Declaration") defines the Class "B" Control Period

as the period of time which the Class "B" Member is entitled to appoint the majority of the members of the Board of Director

WHEREAS, the Declaration defines the sole Class "B" Member as the Declarant;

WHEREAS, the Class "B" Control Period has not expired;

WHEREAS, the Articles of Incorporation grant the Declarant the right to amend the Articles of Incorporation

during the Class "B" Control Period, and the Declarant hereby amends Paragraph 9 to read as follows:

9. Board of Directors: The affairs of the Association shall be managed by a Board of odd number with not less than (3) Directors prior to the termination of the Class "B" Control Period and no less than (5) Directors after the termination of the Class "B" Control Period. Board members shall be appointed or elected as stated in the Bylaws.

Prior to the termination of the Class "B" Control Period, the Declarant shall have the right to appoint all members of the Board in its sole and absolute discretion.


