**ARTICLES OF INCORPORATION OF
GATES AT SOUNDSIDE HOMEOWNERS' ASSOCIATION, INC.,
A FLORIDA NOT FOR PROFIT CORPORATION**

The undersigned incorporator by these articles associates himself for the purpose of forming a corporation not for profit under the laws of the State of Florida, and adopts the following articles of incorporation:

**ARTICLE I
NAME**

The name of this corporation is Gates at Soundside Homeowners' Association, Inc. For convenience, the corporation shall be referred to in this instrument as the "Association," these articles of incorporation as the "Articles," and the bylaws of the Association as the "Bylaws."

**ARTICLE II
TERM OF EXISTENCE**

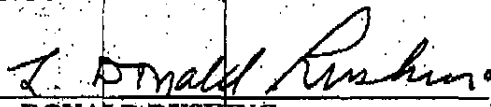

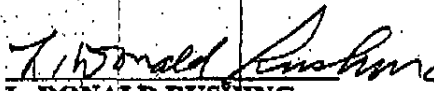
