## ARTICLES OF INCORPORATION OF COCOA TENNIS AND LEARNING CENTER, INC.

### In Compliance with Chapter 617, F.S., (Not for Profit)

#### **ARTICLE I - NAME**

The name of this corporation is COCOA TENNIS AND LEARNING CENTER, INC.

#### ARTICLE II - PRINCIPAL OFFICE

The principal office is located at 1970 Michigan Avenue, Building D, Cocoa, Florida 32922.

#### **ARTICLE III - PURPOSE**

This corporation shall have the power to do any act in business or commerce as is now or hereafter may be authorized under the provisions of Chapter 617, Florida Statutes 2013.
