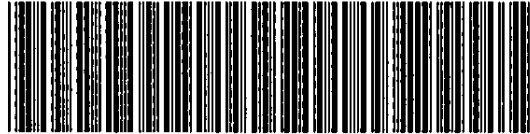

## ARTICLES OF INCORPORATION

### ARTICLE I: NAME

The name of the corporation shall be: The Harvest Recovery Ministry, Inc.

### ARTICLE II: PRINCIPAL OFFICE

### ARTICLE III: PURPOSE

The purpose for which the corporation is organized: To have a faith based meeting, including classes, for anyone suffering with alcohol/drug addiction or any "life controlling" problems and their families. To provide the participants and their families the tools needed to help them succeed.

### ARTICLE IV: NOT FOR PROFIT

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the Statement of Purpose hereof. The property of this corporation is irrevocably dedicated to the furtherance of the non-profit purpose of this organization, and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual.

### ARTICLE V: PROHIBITED POLITICAL AND LEGISLATIVE ACTIVITY

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to
