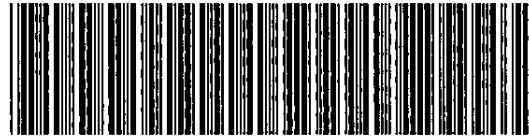

Articles of Incorporation

Of

Agency of Hope, Inc.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

I.

The name of the corporation shall be: Agency of Hope, Inc.

II.

The principal place of business and mailing address of this corporation shall be:

1250 Peacefield Drive Jacksonville, Florida 32205

III.

The specific purpose(s) for which the corporation is organized is (are): The corporation is organized pursuant to the Florida Nonprofit Corporation Code. This corporation is a nonprofit public benefit organization and is not organized for the private gain of any person. Its principal strategies of operation will focus on charitable and educational programs. Its purpose is to promote and establish a full service facility, which will provide a complete continuum of care ; ranging from preventative to the treatment and rehabilitation of children, youth, adults, elderly, veterans, persons with Aids/HIV, persons with developmental disabilities, and families. The service goals are to provide support and technical assistance in order to offer quality services in a less restrictive environment, and to provide support services and monitoring to the court system, and state agencies. The agenda will include, but shall not be limited to mental health Counseling, both traditional and holistic, case management, specialized parent education, preventative services for family violence and non violent juvenile offenders, educational services for deprived, disadvantaged, disabled individual; counseling services for crime victims , drug addicted adults, veteran with PTSD, HIV/AIDS patients, delinquent and deprived children and their families; in-home and community based services for people with disabilities, HIV/AIDS patients, pre and postnatal parents, and the elderly. To provide emergency adult day care, respite care, housing, transportation, food, clothing, furniture, employment, and food for low income families at risk of deprivation. To provide stable and safe housing/ group homes for the elderly and HIV/AIDS patients, and persons with developmental disabilities; and nursing services, medication administration and management, HIV/AIDS testing, and health education. This corporation will coordinate and function in cooperation with federal, state, county, and local agencies as well as local churches, civic organizations, and private business.
