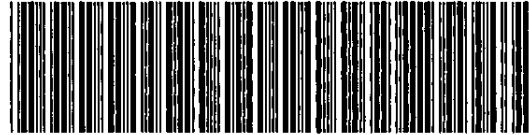

**ARTICLES OF INCORPORATION
OF
SARAH'S KITCHEN OF THE TREASURE COAST, INC.**

UNDER CHAPTER §617 OF FLORIDA STATUTES (F.S.)

THE UNDERSIGNED INCORPORATOR, for the purpose of forming a corporation under the Florida Business Corporations Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is SARAH'S KITCHEN OF THE TREASURE COAST, INC.

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III. PURPOSE

The specific purpose for which this corporation is organized is:

In response to God's Love and in the scriptural spirit of hospitality; Our purpose is to welcome and feed those in our community who are hungry.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the internal revenue code, or correspondence section of any future federal tax code.

ARTICLE IV. DISSOLUTION

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such asset not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
