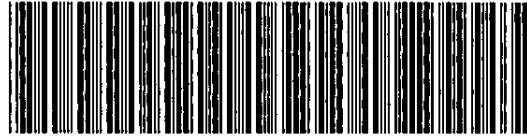

# ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S. (Not for Profit)

## ARTICLE I NAME

The name of the corporation shall be:

**From Bondage to Freedom Outreach Ministry, Inc.**

## ARTICLE II PRINCIPAL OFFICE

## ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

To train, encourage and develop young to mature women for Christian leadership and service. Educating and equipping them on how to move from a state of brokenness to a whole, healthy and solid foundation to further enrich their home, children, family and local community. The corporation is organized exclusively for charitable, religious and educational purposes, including, for such purposes, the making of distributions to organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

## ARTICLE IV MANNER OF ELECTION The manner in which the directors are elected and appointed:

The initial Board of Directors has been appointed by the Incorporator. Future Board of Directors to be selected via annual elections, after nominees are determined through the review board selection process. Future vacancies are to be filled by appointment of the Incorporator/Director, as deemed necessary or until elections can be held. Upon the dissolution of the Corporation, the Board of Directors shall, after paying or adequately providing for all the debts, obligations and liabilities of the Corporation, distribute the remaining assets of the Corporation exclusively for the nonprofit religious purposes and shall distribute the remaining assets of the Corporation to such organization or organizations which are tax exempt under section 501(c)(3) of the Code, as the Board of Directors in its sole discretion shall determine.

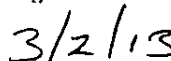

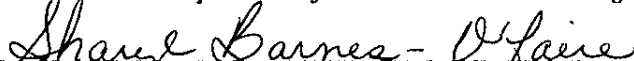

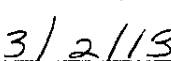
