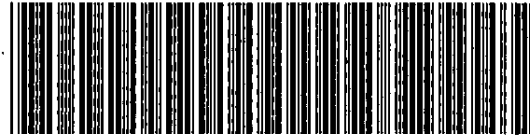

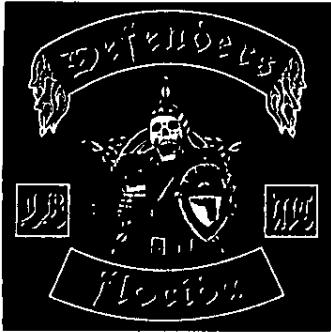

ARTICLE I: NAME

The name of the corporation shall be:


ARTICLE VIII: OWNERSHIP
