# ARTICLES OF INCORPORATION OF NORMAN MAJORS FOUNDATION, INC. (A Not for Profit Corporation)

The undersigned, Tim Majors, acting as incorporator of the Norman Majors Foundation, Inc., a corporation under the Florida Non For Profit Corporation Act, hereby adopts the following Articles of Incorporation for such Corporation:

#### **ARTICLE I - NAME**

The name of the corporation shall be the Norman Majors Foundation, Inc.

#### ARTICLE II - PURPOSE-POWERS

The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of Section 501(c)(3) of the Internal Revenue Service of 1986 or the corresponding provisions of any future United States Internal Revenue law. The corporation shall provide services to the general public that promote the general welfare and public good.

The general nature, objects and purposes of the corporation shall be to operate without profit and to accept and receive property of whatever kind, and wherever situated, receive by it by gift, grant, purchase, devise, bequest, or any lawful manner and to administer and distribute such property exclusively for charitable purposes, including:

- a) To distribute property in accordance with the terms of gifts, bequest, or devises made to the corporation which are not inconsistent with its purposes;
- b) To modify any restriction or condition on the administration and distribution of funds for any specified purpose consistent herewith if in the sole judgment of the board of directors, such restriction or condition becomes, in effect, unnecessary, incapable of fulfillment, or inconsistent with the designated purposes of the corporation.

#### ARTICLE III - LIMITATIONS

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its

members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for a public office.

Notwithstanding any other provisions of these Articles, the corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal Income Tax under Section 501(c)(3), of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

To do all and everything necessary, suitable or proper for the accomplishment of any of the purposes or the attainment of anyone or more of the purposes herein stated, incidental to the powers that appear conducive or expedient for the promotion of its welfare, purposes herein stated.

#### ARTICLE IV - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State, unless dissolved according to Florida Law.

#### ARTICLE V - DISPOSITION OF ASSETS ON DISSOLUTION

If upon the dissolution of the corporation, the board of directors shall, after paying or making provisions for the payment of all of the liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purposes for which this corporation was organized to such organization or organizations organized and operated exclusively for charitable, educational, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States Revenue Law.

#### **ARTICLE VI - MEMBERSHIP**

The corporation shall not have any members.

#### ARTICLE VII - INCORPORATOR
