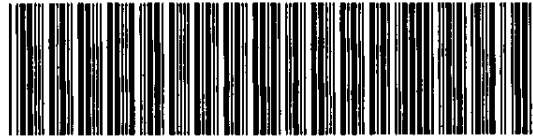

We, the undersigned subscribers, all being of full age, have associated ourselves together for the purpose of forming a corporation not-for-profit under the Chapter 617, State of Florida Statutes, hereby adopts the following Articles of Incorporation:

**ARTICLE I**

**Name**

The name of this corporation is Boynton Hill Church of God in Christ, Inc.

**ARTICLES II**

**Duration**

The term of existence of the corporation is perpetual.

**ARTICLE III**

**Principal**

The principal place of business and mailing address of this corporation shall be: 722 NW 2<sup>nd</sup> Street, Boynton Beach, Florida 33435

**ARTICLE IV**

**Purpose**

The specific purpose(s) for which the corporation is organized is (are): The Corporation is not formed for pecuniary or financial gain, and no part of the assets, income of the corporation is inures of the benefit of its directors or officers. It is organized to be and operated as Christian Church exclusively for charitable, educational and scientific purposes.

**ARTICLE V**

**Officers**

**Officers and Management:** The officers of this not-for-profit corporation shall be a President, Secretary and Treasurer. Management shall be vested in a board of directors; consisting of at least six (6) and no more than twenty five (25) of the members.

##### **Dissolution Statement**

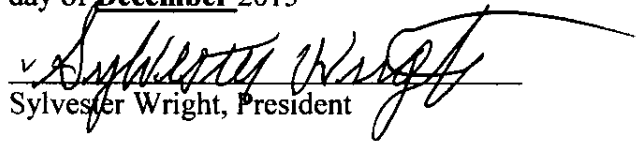

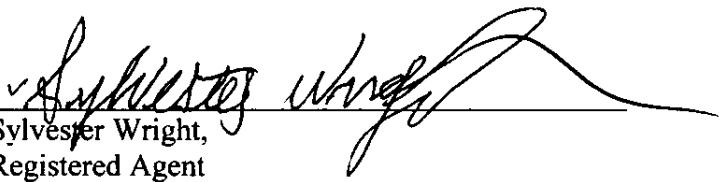
