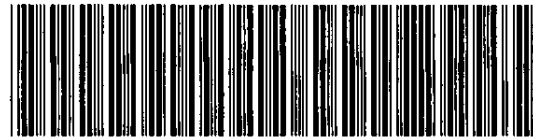

**AMENDING ARTICLE III**

Kirby Family Farm, Inc. by and through it's incorporator and officers, would like to make the following changes to Article 3 of the Articles of Incorporation. Language: "The purpose of the corporation is exclusively for religious, charitable, scientific, literary, or/ and educational purposes, including the making of distributions under 501(c)(3) or IR code" should be struck.

Kirby Family Farm, Inc., by and through it's incorporator and officers, would like to adopt the new language listed below for Article 3.

"Kirby Family Farm is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the →
