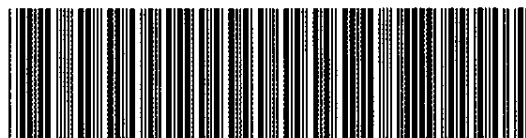

FOR

ARTICLE I NAME

The name of the corporation shall be: Friends of SEDO International, Inc.

ARTICLE II PRINCIPAL OFFICE
