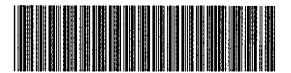

ARTICLES OF INCORPORATION

OF

THE CHURCH OF MOST HIGH CHRSTIAN CHURCH

ARTICLE 1 NAME OF CORPORATION

The name of the corporation shall be CHURCH OF MOST HIGH CHRSTIAN CHURCH INC. The principal place of business for the corporation shall be 10444 Southeast 54th Court, Belleview, Florida 34420.

ARTICLE 2 PURPOSE

The general purpose of this corporation shall be to serve God, and to exercise all of the rights and powers granted unto corporations for non profit under the laws of the State of Florida as they presently exist, or as they may hereafter exist, either by new acts or by amendatory acts.

ARTICLE 3 REGISTERED AGENT

The initial registered office of the corporation is 10444 Southeast 54th Court, Belleview, Florida 34420. The initial registered agent at that address is NECITA STALEY CRAWLEY, who, by her signature below, accepts the designation for service of process.

ARTICLE 4 MEMBERSHIP

The Corporation shall have members. Members will receive membership certificates which shall be a form approved by the Board of Directors.

MEMBERSHIP IS GOVERNED BY THE CONSTITUTION OF CHURCH OF MOST HIGH CHRISTIAN CHURCH INC.

ARTICLE 5 PERPETUAL EXISTENCE

The corporation shall have perpetual existence.

There shall be three (3) members of the initial Board of Directors of the corporation, and there shall never be less than three (3) directors. The affairs of the corporation are to be managed by the Board of Directors. Directors are to be elected at the annual meeting of members by a majority vote of members, as set out in the by-laws.

ARTCLE 7 OFFICERS

The day to day affairs of the corporation, subject to the approval of the Board of Directors, shall be managed by a president, a vice-president, a secretary and a treasurer. Officers will be elected annually by the Board immediately after the annual election of the Board. provided, however, that the Board, may veto such amendment, which can be overridden only be a two-thirds majority vote of the membership.

This Corporation may apply for grants, established bank accounts or place corporate assets in trust or invest in such properties as would a fiduciary under the laws of the State of Florida, the Corporation being held, as to such investments, to the same standards as a fiduciary.
