Article 1.

The name of the corporation is Hindu Heritage Foundation, Inc.

Article 2.

The name and Florida street address of the Registered Agent: Ramesh Gangisetti; 3545 St. Johns Bluff, Suite 349, Jacksonville, FL. 32224

Article 3.
