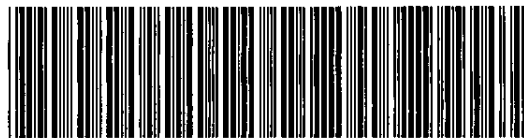



To establish structured support service for Evangelistic, Economic Development and Other Ministries to support the outreach ministries for the body of Jesus Christ in accordance with the Doctrine of the corporation by-laws. The religious program will consist of Economic Development Programs, but, shall no be limited to: Homeless, Health Care, Child Care, Youth At High Risk, Tutorial, Land Acquisition, Housing, Job Training, Counseling, Employment and other programs to aid those in need.
- THREE:** The duration of this corporation shall be perpetual, no stock and shall have no members.



Any such asset not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such or organizations, said court shall determine which are organized and operated exclusively for such purposes.
