# Seek 2 Soar Outreach, Inc. AMENDED ARTICLES OF INCORPORATION

The undersigned, incorporator, for the purpose of forming a Florida not-for-profit corporation, hereby adopts the following Articles of Incorporation:

#### ARTICLE I

#### 1.01 NAME

The name of this corporation shall be Seek 2 Soar Outreach, Inc. The business of the corporation may be conducted as Seek 2 Soar Outreach, Inc.

#### ARTICLE II

#### 2.01 DURATION

The period of duration of the corporation is perpetual.

#### ARTICLE III

#### 3.01 PURPOSE

Seek 2 Soar Outreach, Inc.is a faith based, Non-Profit corporation and shall operate exclusively for educational and charitable purposes within the meaning of Section 501 (e)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code.

The purpose for which Seek 2 Soar Outreach, Inc. exist is to reduce homelessness and improve their quality of life among single mothers who experienced a traumatic life event through our transitional housing and mentoring programs and services. Our service delivery model is based upon the 5 principles of Trauma Informed Care while demonstrating the LOVE of Christ, RESTORE hope, and INSPIRE change. Our wraparound services include case management, counseling, coaching, mentoring, support groups, and workforce readiness preparation.

More specifically, our transitional housing program will provide a safe place to rest during their time of transition. Our Case management services will assess individual personal need and assist with coordination of services. Our mentoring program will utilize the Seek 2 Soar Transformation Curriculum that is designed to educate, encourage and equip the women to live a life of peace, purpose, and prosperity and advocate for the betterment of their family and community. It consists of Christian counseling to focus on healing from past traumas, learning to LOVE their imperfect self through a perfect savior, RESTORE hope, and learn spiritual disciplines and coping skills. Through our mentoring and tife skills support groups, they will learn skills necessary to create a positive self-image and chart a new path. Through our Christian Success Coaching service, residents will set goals, develop an action plan, and assess progress towards achieving success desired. Lastly, through our workforce readiness preparation, residents will learn skills that will allow them to gain employment and reach self-sufficiency.

Seek 2 Soar Outreach, Inc. shall not be conducted or operated for profit and no part of the net earnings of Seek 2 Soar Outreach, Inc. shall inure to the henefit of any individual, nor shall any of the profits or assets of Seek 2 Soar Outreach, Inc. be used other than for the purposes of Seek 2 Soar Outreach, Inc.

#### ARTICLE IV

#### 4.01 NON-PROFIT NATURE

Seek 2 Soar Outreach, Inc. is organized exclusively for charitable and educational purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

No part of the net earnings of Seek 2 Soar Outreach, Inc. shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that Seek 2 Soar Outreach, Inc. shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause in Article 3.01 hereof.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of this document, Seek 2 Soar Outreach, Inc. shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

#### 4.02 PERSONAL LIABILITY

No officer or director of Seek 2 Soar Outreach, Inc. shall be personally liable for the debts or obligations of Seek 2 Soar Outreach, Inc. of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of Seek 2 Soar Outreach, Inc.

Seek 2 Soar Outreach, Inc. shall indemnify any director, officer, or former director or officer of Seek 2 Soar Outreach, Inc. or any person who may have served at its request against expenses actually and reasonably incurred by him or her in connection with the defense of any action, suit or proceeding, civil or criminal, in which he is made a party by reason of being or having been an officer or director of Seek 2 Soar Outreach, Inc., except in relation to matters as to which he or she is adjudged in such action, suit, or proceeding to be liable for negligence or misconduct in the performance of his or her duty to Seek 2 Soar Outreach, Inc.

#### 4.03 DISSOLUTION

Upon termination or dissolution of Seek 2 Soar Outreach, Inc., any assets lawfully available for distribution shall be distributed to one (1) or more qualifying organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986 (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving corporation.

The organization to receive the assets of Seek 2 Soar Outreach, Inc. hereunder shall be selected by the discretion of a majority of the managing body of the Seek 2 Soar Outreach, Inc. and if its members cannot so agree, then the recipient organization shall be selected pursuant to a verified petition in equity filed in a court of proper jurisdiction against the Seek 2 Soar Outreach, Inc. by one (1) or more of its managing body which verified petition shall contain such statements as reasonably indicate the applicability of this section. The court upon a finding that this section is applicable shall select the qualifying organization or organizations to receive the assets to be distributed, giving preference if practicable to organizations located within the State of Florida.

In the event that the court shall find that this section is applicable but that there is no qualifying organization known to it which has a charitable purpose, which, at least generally, includes a purpose similar to this corporation, then the court shall direct the distribution of its assets lawfully available for distribution to the Treasurer of the State of Florida to be added to the general fund.

#### 4.04 PROHIBITED DISTRIBUTIONS

No part of the net earnings, or properties of Seek 2 Soar Outreach, Inc. on dissolution or otherwise, shall inure to the benefit of, or be distributable to, its members, directors, officers or other private person or individual, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III, Section 3.01.

#### 4.05 RESTRICTED ACTIVITIES

No substantial part of Seek 2 Soar Outreach, Inc. activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and Seek 2 Soar Outreach, Inc. shall not participate in, or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.

#### 4.06 PROHIBITED ACTIVITIES

Notwithstanding any other provision of these Articles, Seek 2 Soar Outreach, Inc. shall not carry on any activities not permitted to be carried on (I) by a corporation exempt from federal income tax as an organization described by Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (II) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### ARTICLE V

#### 5.01 BOARD OF DIRECTORS

Subject to the limitations contained in these Articles of Incorporation, and to the provisions of law requiring corporate action to be exercised, authorized, or approved by the members of Seek 2 Soar Outreach, Inc., all the lawful powers of Seek 2 Soar Outreach, Inc. shall be vested in and exercised by or under the authority of the board of directors, and the business and affairs of Seek 2 Soar Outreach, Inc. shall be conducted and controlled by such board.

#### 5.02 INITIAL DIRECTORS
