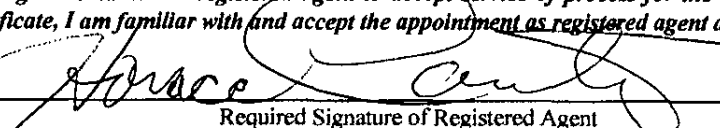

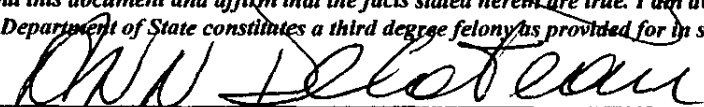

Article VIII

PURPOSE

The Corporation is organized exclusively for charitable and educational purposes within the meaning of Section 501 C 3 of the Internal Revenue Code of 1986, as amended, or to any corresponding provision of any future federal tax law.

Limitations and Dissolution statement

The Corporation is not organized and shall not be operated for pecuniary gain or profit. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributed to its members, trustees, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding, any other provision of this document, the Corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under section 501 C 3 of the Internal Revenue Code, or corresponding section of any future federal tax code or by an organization, contributions to which are deductible under section 170 C 2 of the Internal Revenue Code or corresponding section of any future federal tax code.

Upon dissolution of the Corporation, to the extent allowed under applicable law, after all lawful debts and liabilities of the Corporation have been paid, all the assets of the Corporation shall be distributed to, or its assets shall be sold and the proceeds distributed to, another organization organized and operating, or to one or more corporations, funds or foundations organized and operating exclusively for religious, charitable, educational and/or scientific purposes, which shall be selected by the board of directors of the Corporation, provided however, that any such recipient organizations shall be at that time qualified as exempt from taxation under the provisions of section 501 (a) of the Internal Revenue Code of 1986, as an organization described in section 501 C 3 of the Internal Revenue Code of 1986, or the corresponding provisions of any subsequent law. In the event that upon the dissolution of the corporation, the board of directors of the corporation shall fail to act in the manner herein provided in the county in which the principal office of the Corporation is locate, the Court of Common Pleas shall make such distribution as herein provided upon the application on one or more persons having a real interest in the Corporation or its assets.
