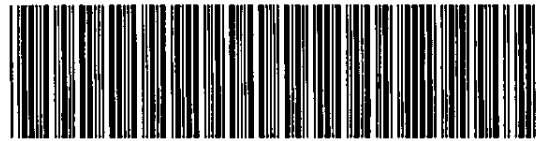

AMENDMENT TO ARTICLE III

Said organization is organized exclusively for chargeable religious educational scientific purposes, including, for such purposes, the making of distributions organizations that qualifies as exempt organizations described under Section 501c3 of Internal Revenue Code, or corresponding sections of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501c3 of the Internal Revenue Code, or corresponding sections of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such asset not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of organization is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine which are organized and operated exclusively for such purposes.


