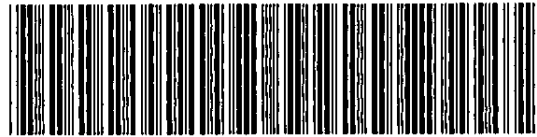



Articles of Incorporation

In Compliance with Chapter 617, F.S., (Not for Profit)

Of

One4All Charity Inc.

Article I

The name of the corporation shall be: One4All Charity Inc.

Article II

The principal place of business and mailing address of this corporation shall be:

8606 Split Rail Lane
Bayonet Point, FL 34667

Article III

One4All Charity Inc. is a public benefit nonprofit corporation that is organized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, including for such purposes, the making of distributions to organizations that qualify as tax-exempt organizations under Section 501(c)(3) of the Internal Revenue Code. Specifically, this nonprofit corporation is organized and operated to actively fundraise and provide financial assistance and support to charitable organizations that are dedicated to helping the poor, distressed, and underprivileged by enhancing the overall quality of life of the individuals.

No part of the net earning of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code, or corresponding provisions of any future United States Internal Revenue Code.

Article IV

The manner in which the directors are elected or appointed: During the annual meeting, the officers shall elect the directors of the corporation.


