

The undersigned Incorporator of these Articles is a natural person competent to contract and hereby form a Corporation for non-profit under Chapter 617 of the Florida Statues.

Article I - NAME

The name of the Corporation is **Joseph Project of America**, **Inc.**, (hereinafter called organization).

Article II - PRINCIPAL BUSINESS
