### ARTICLES OF INCORPORATION **OF** EDGEWOOD CEMETERY ASSOCIATION, INC. 13 APR 11 PM 12: 57

### A Florida "Not for Profit" Corporation

The undersigned, acting as incorporator of a corporation under Chapter 617 of Florida Statutes, adopts the following Articles of Incorporation:

### ARTICLE I NAME OF CORPORATION

The name of the corporation is Edgewood Cemetery Association, Inc. (may be referred to as "corporation")

#### **ARTICLE II** PRINCIPAL OFFICE

The principal office of the corporation is located at 1217 Stratton Avenue, Groveland, Florida 34736.

### ARTICLE III **MAILING ADDRESS**

The mailing address of the corporation is 1217 Stratton Avenue, Groveland, Florida 34736.

#### ARTICLE IV REGISTERED AGENT

The address of the initial registered office of this corporation is 1217 Stratton Avenue, Groveland, Florida 34736. The name and address of the Registered Agent of this corporation is James Smith, 1217 Stratton Avenue, Groveland, Florida 34736.

### **ARTICLE V** INITIAL BOARD OF DIRECTORS

The management of the Corporation shall be vested in the Board of Directors. The number of Directors constituting the initial Board of Directors is three. The number of Directors may be increased or decreased from time to time in accordance with the Bylaws, but shall never be less than three. ### ARTICLE V COMMENCEMENT OF CORPORATE EXISTENCE AND DURATION

#### ARTICLE VII CORPORATE PURPOSES

Edgewood Cemetery Association, Inc. is organized exclusively for charitable purposes including for

such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

### ARTICLE VIII NO PRIVATE INUREMENT

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its officers, directors, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

#### ARTICLE IX LOBBYING AND POLITICAL CAMPAIGNS

No substantial part of the activities of the Corporation shall consist of carrying on propaganda, or otherwise attempting, to influence legislation (except as otherwise provided by Section 501(h) of the Code), or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office.

### ARTICLE X 501(c)(3) LIMITATIONS

Notwithstanding any other provision hereof, the Edgewood Cemetery Association, Inc. shall not carry on any other activities not permitted to be carried on (i) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code of 1986 or the corresponding provision of any future United States Internal Revenue law, or (ii) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Code (or the corresponding provision of any future federal tax code).

### ARTICLE XI DISSOLUTION


Upon the termination, dissolution or final liquidation of the Edgewood Cemetery Association, Inc. in any manner and for any reason, the Board of Directors shall first pay or provide for the payment of all liabilities of the corporation; all remaining assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding section of any future United States Internal Revenue law, or shall be distributed to the federal government, or to state or local government, for a public purpose.
