

The undersigned, for the purpose of forming a not-for-profit corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

**ARTICLE I.**

**NAME**

The name of this corporation shall be **BINDING INTERNATIONAL AND GLOBAL EFFORTS YIELDING TO END STARVATION, INC.** (hereinafter called the "Corporation").

**ARTICLE II.**

**PRINCIPAL OFFICE AND MAILING ADDRESS**

**ARTICLE III.**

**PURPOSE**

The specific purpose of this not-for-profit corporation is for the charitable, religious and educational training purposes in Section 501(c)(3) of the Internal Revenue Code 1986 and for the purpose of engaging in any lawful act or activity not for pecuniary profit for which not-for-profit corporation may be organized, so for as is or may be permitted by law of the state of Florida and Section 501(c)(3) of the Internal Revenue Code 1986 as amended.

The specific purpose of Binding International and Global Efforts Yielding to End Starvation, Inc. Our mission is to provide relief to impoverished communities and countries where starvation is an epidemic. We fulfill this mission through advocacy, financial resources, food and/or access to affordable and nutritious food to as many impoverished and starving families as we can reach. We aspire to collaborate with other grassroots and global initiatives which provide universal access to nutritious food for impoverish and starving families. Our main objective is to provide aid and reduce hunger while addressing societal mechanisms by which people are denied access to healthy, nutritious and culturally appropriate food.



which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code 1986, as amended, or corresponding provision of any subsequent federal tax laws.

**ARTICLE VIII.**  
**LIMITATIONS**

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributed to its Director, Officers, Members, or other private person, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payment and distributions in furtherance of any of its purposes. No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislations (except as otherwise provided in subsection (h) of Section 501(c)(3) of the Internal Revenue Code 1986, as amended), and the Corporation shall not participate or intervene in (including the publishing or distribution of statement) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law), or (b) by a corporation, contributions to which are deductible under Section 170(c) 2 of the Internal revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law).


