WE, THE UNDERSIGNED, DO JOINTLY AND SEVERALLY AGREE WITH EACH OTHER TO ASSOCIATE OURSELVES AND OUR SUCCESSORS TOGETHER AS A CORPORATION NOT FOR PROFIT UNDER CHAPTER 617 OF THE LAWS OF THE STATE OF FLORIDA, AND DO HEREBY SUBSCRIBE AND ACKNOWLEDGE THE FOLLOWING ARTICLES TO WIT:

ARTICLE I

THE NAME OF THE CORPORATION IS:


