Article II The principal place of business is 13150 Annadale Dr. S. Jacksonville, FI 32225 Article III The purpose of the corporation is exclusively for charitable, religious, educational and scientific purposes including for such purpose, the making of distributions to organizations that qualify as exempt organizations under 501(c)(3) of the Internal Revenue Code, or the corresponding section of any federal tax code and herein stated as follows: The non profit corporation Jump For Kids, Inc. is being formed to provide under privileged students kindergartner through 8th grade with free personal training. Training to include; fitness knowledge, higher self esteem, stronger bodies, nutrition information, and to learn the range of motion of exercises that will be used in personal fitness the rest of their life. With accomplishing these fitness life skills the students benefit because when they go onto high school and their adult life they will know more about practical exercises that can be applied to their personal fitness. Jump For Kids, Inc. will achieve its purpose by fund raising and applying for grants. The funds allow Jump For Kids, Inc., to offer the program free to schools. Currently the program is in The Beaches School Neptune Beach, Florida from fall of 2010 to present.

Article VIII Distributions Upon Dissolution: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, shall be distributed to the federal government or to a state or local government, for a public purpose. Any such assets not so disposed of shall be be disposed of by a Court of Competent Jurisdiction of the county in which the organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
