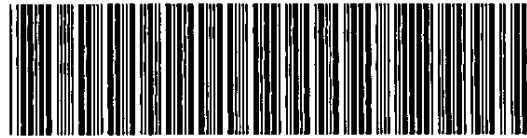

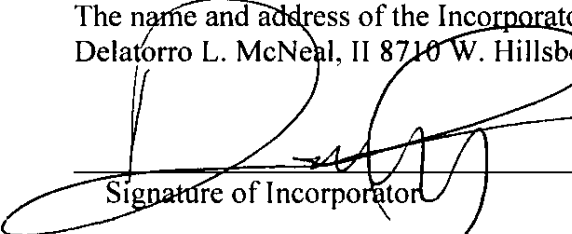
ARTICLE VI – DISSOLUTION
