ARTICLES OF INCORPORATION

CLEVELAND CLINIC FLORIDA PHARMACY SERVICES . NONPROFIT CORPORATION

ARTICLE III: PURPOSE

Cleveland Clinic Florida Pharmacy Services Nonprofit Corporation (the "Company") is organized for the purpose of engaging in and providing healthcare services, and carrying on certain related professional activities. It is intended that these services and activities will be conducted at the hospital facilities and medical offices of Cleveland Clinic Florida Health System (a Nonprofit Corporation) and Cleveland Clinic Florida (a nonprofit corporation). The Company is organized and shall be operated exclusively for charitable, educational and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now in effect or as may hereafter be amended (and to the corresponding provisions of any similar laws subsequently enacted and to all regulations issued under those sections and provisions) (the "Code"), and for the benefit of, to perform the functions of, and to carry out the purposes of Cleveland Clinic Florida (a Nonprofit corporation) which is organized and operated exclusively for charitable, educational, and scientific purposes. In addition to the foregoing, at all times the Company shall be supervised or controlled by Cleveland Clinic Florida (a Nonprofit corporation).

ARTICLE IV: MANNER OF ELECTION

The Board of Directors will be elected during each annual meeting of the Company or from time to time, as needed.
