## ARTICLES OF INCORPORATION of FRIENDS OF THE "BABE" JAMES CENTER, INC.

The undersigned, a citizen of the United States and desiring to form a Non-Profit Corporation under the Non-Profit laws of the State of Florida, does hereby certify as follows:

ARTICLE ONE - NAME: The name of the corporation shall be FRIENDS OF THE "BABE" JAMES CENTER, INC.

ARTICLE TWO - PRINCIPAL OFFICE: The place where the principal office of the corporation is to be located is:

201 North Myrtle Avenue, New Smyrna Beach, Volusia County, Florida.

The mailing address of the principal office is:

Post Office Box 2324, New Smyrna Beach, Florida, 32170

**ARTICLE THREE - PURPOSE:** Said corporation is organized exclusively for charitable, religious, educational and scientific purposes, including in such purposes the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE FOUR – INITIAL DIRECTORS: The number of persons constituting the first board of directors is three. The names and addresses of the persons who are the initial directors of the Corporation are:

Robert Brown, 1407 North Peninsula Avenue, New Smyrna Beach, FL 32169

The total number of directors the Corporation may have, which shall be no less than three, and the manner in which they are to be elected or appointed shall be stated in the corporate bylaws.

**ARTICLE FIVE – INCORPORATOR:** The name and address of the incorporator is:

ARTICLE SIX – LIMITATIONS OF CORPORATE POWERS: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and

empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislations, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any further federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any further federal tax code.

ARTICLE SEVEN – DISTRIBUTION OF ASSETS UPON DISSOLUTION: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any further federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purpose. Any such assets not so disposed of shall be disposed of by a Court of competent jurisdiction of the County in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as the Court shall determine, which are organized and operated exclusively for such purposes.
