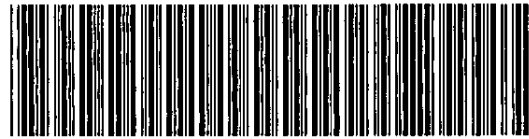

**ARTICLES OF INCORPORATION
OF
INSTITUTE OF PUBLIC SAFETY, INC.**

The undersigned incorporator, for the purposes of forming a Florida not-for-profit corporation, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the Corporation is: Institute of Public Safety, Inc.

ARTICLE II

DEFINITIONS

For the purposes of these Articles of Incorporation, the terms herein referred to shall have the following meaning:

1. The term "Act" means the Florida Not For Profit Corporation Act, or any successor law, as the same may be amended from time to time.
2. The term "Bylaws" means the Bylaws of the Corporation, as the same may be further amended or revised from time to time.
3. The term "Code" means the Internal Revenue Code of 1986, as it may be amended from time to time or comparable provisions of subsequent legislation.
4. The term "Corporation" means Institute of Public Safety, Inc., a Florida not for profit corporation, unless, from the context or use, it clearly has a different meaning.
5. The term "Member" means Institute of Public Safety, Inc. in its capacity as sole member of the Corporation.

ARTICLE III

PRINCIPLE OFFICE

The address of the Corporation's principle place of business and the mailing address of the Corporation:

ARTICLE IV

PERIOD OF DURATION

The period of duration of the Corporation shall be perpetual.

ARTICLE V

PURPOSES

The Corporation is organized exclusively for charitable, scientific, or educational purposes within the meaning of Section 501(c)(3) of the Code and in the course of such operation:

1. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributed to its Member, trustees, directors, officers or other private individuals, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered.
2. No substantial part of activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) and political campaign on behalf of or in opposition to any candidate for public office in violation of any provisions applicable to corporations exempt from taxation under Section 501(a) as organizations described in Sections 501(c)(3) of the Code and the regulations promulgated thereunder as they now exist or as they may be hereafter amended.

ARTICLE VI

BOARD OF DIRECTORS

The directors shall be elected or appointed as provided in the Bylaws of the Corporation.


ARTICLE VII

INCORPORATOR ADDRESS AND NAME

DISSOLUTION



Any such assets not disposed of shall be disposed of shall be disposed of by the Court of Common Pleas of the county in which the principle office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
