Section 7.7 of the Articles is hereby amended as follows:

7.7 To dedicate, grant, license, lease, concession, create easements upon, sell or transfer all or any part of Longleaf Woodland Terrace at Timber Springs to any public agency, entity, authority, utility or other person or entity for such purposes and subject to such conditions as it determines and provided in the Declaration;

Section 7.9 of the Articles is hereby amended as follows:

7.9 To adopt, publish, promulgate or enforce rules, regulations, covenants, restrictions or agreements governing the Association, Longleaf Woodland Terrace at Timber Springs, the Common Areas, Lots and, as provided in the Declaration, to effectuate all of the purposes for which the Association is organized;


