Pursuant to the provisions of Section 617.1006, Florida Statutes, this Florida not-for-profit corporation adopts the following amendment(s) to the Articles of Incorporation for Longleaf Master Homeowners' Association, Inc. (the "Articles");

Section 7.2 of the Articles is hereby amended as follows:

7.2 to enforce, by legal action or otherwise, the provisions of the Declaration and By-Laws and of all rules, regulations, covenants, restrictions and agreements governing or binding the Association and Longleaf Woodland Terrace at Timber Springs;

Section 7.7 of the Articles is hereby amended as follows:

7.7 To dedicate, grant, license, lease, concession, create easements upon, sell or transfer all or any part of Longleaf Woodland Terrace at Timber Springs to any public agency, entity, authority, utility or other person or entity for such purposes and subject to such conditions as it determines and provided in the Declaration;

Section 7.9 of the Articles is hereby amended as follows:

7.9 To adopt, publish, promulgate or enforce rules, regulations, covenants, restrictions or agreements governing the Association, Longleaf Woodland Terrace at Timber Springs, the Common Areas, Lots and, as provided in the Declaration, to effectuate all of the purposes for which the Association is organized;
