NONPROFIT ARTICLES OF INCORPORATION

HEROES FOR CHRIST MINISTRY, INC.

The undersigned incorporators, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, section 617, Florida Statutes, hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation shall be:

HEROES FOR CHRIST MINISTRY, INC.

ARTICLE - II - EXISTENCE

The Non-profit Corporation shall have perpetual existence.

ARTICLE - III - PRINCIPAL OFFICE

The principal headquarters and mailing address of this organization shall be:

ARTICLE - IV - PURPOSES AND OBJECTIVES

The specific purpose for which the corporation is organized is:

To provide community services and financial support and resources to Christian missionaries across the world through evangelistic activities by missing funds and to provide cultural awareness and Christian education. To help the needed people in regards to cloth, food, housing. To support missionary events and to help develop better living conditions for those in need. To demonstrate the love of God through voluntary community services. To engage in the production of Christian media and movies to support engage in the Christian gospel and the good word of God.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities

of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization

shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign a behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

- A. To organize and operate charitable fund for the needy and fosters and senior citizens care center.
- B. To develop and organized Christian educational organization at difference levels, including a childcare center to the general public.
- C. To sell, distribute, purchase or acquire in any lawful manner Christian literature and music in the form of book, tape, disk, cassette, compact disk, or in any other possible form.
- D. To give Christian crusades, television and radio programs, and live concerts around the world.
- E. To invest the funds of this corporation in real estate, mortgages, or any other type of investment, and to own real and personal property necessary for the corporation purposes.
- F. To do all and everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objectives or the furthermore of any of the purposes enumerated in these Articles of Incorporation or any amendment hereof necessary and incidental the protection and benefit of the corporation, and, in general, either alone or in or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment of the purposes or objectives of this corporation.
- G. The foregoing paragraphs shall be construed as enumerating both Objects and purposes of this nonprofit corporation and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of this corporation otherwise permitted by law.

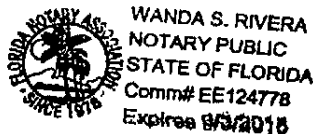
