# Article III

## (b) Dissolution:

Upon the dissolution of the organization, the board of directors shall after paying or making provisions for the payment of all liabilities of the organization dispose of all of the assets of the corporation exclusively for the purpose of the organization in such manner or to such organizations organized and operated exclusively for charitable educational religious or scientific purposes as shall at the time qualify as an exempt organization or organizations under title xxvi section 501(c)(3) of the internal revenue code of 2004 and its regulations as they now exist or as they may hereinafter be amended as the board of directors shall determine. Any of which the principal office of the corporation is then located exclusively for such purposes or to such organization or organization or organizations as said court shall determine which are organized and operated.

# (C) Prohibited Actions:

Inurement of Income. No part of the net earning of the organization shall inure to the benefit of or be distributable to its members director officers or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered to and to make payments and distributions in furtherance of the purposes set forth hereof.

Political Activities. No substantial part of the activities of Organization shall be for the purpose of lobbying or supporting political candidates. The organization shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. This clause does not prohibit the Organization from participating in activities that educate and/or bring awareness to public policies.
