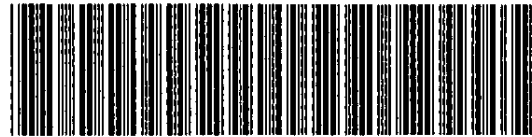

ARTICLE OF INCORPORATION OF
DISCIPLES MINISTRY CENTER, INC.

We, the undersigned, hereby associate ourselves for the purpose of becoming a non-profit corporation under the of the State of Florida, by and under the provisions of the statutes of the State of Florida providing for the information, liability, rights, privileges and immunities of a corporation not for profit.

ARTICLE I

Name

The name of the corporation shall be: DISCIPLES MINISTRY CENTER, INC. Hereinafter, sometimes referred to as: the Organization.

ARTICLE II

Duration

DISCIPLES MINISTRY CENTER, INC. shall have a perpetual existence.

ARTICLE III

Purpose

The purpose of DISCIPLES MINISTRY CENTER, INC is organized exclusively for religious, charitable, education and gospel driven purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of Internal Revenue Code, or corresponding section of any future federal tax code; to that end, adopt and establish by-laws and make all rules and regulations deemed necessary and expedient for the management of its affairs in accordance with the law and not inconsistent with these Articles of Incorporations;

To acquire, buy, hold, own, sell, exchange, convey, lease, or otherwise dispose of goods, chattels effects and merchandise; To mortgage, lease, hypothecate, convey, exchange, and dispose of lands and chattels, to acquire, by gift annuity, bequest, or otherwise, property, both real and personal, or otherwise, and to promote the diffusion of religious literature and education loyal to Jesus-Christ's faith as held by the Church of Christ; DISCIPLES MINISTRY CENTER, INC shall establish temple or a worship center for its member to conduct religious activities such as worship and Adoration services, Bible Study, praying for the sick, teaching the words of God,

and care for the needed in the community, establish school to educate its members and promote its beliefs. To do anything and everything pertinent to the above.

ARTICLE IV MANAGEMENT

The affairs of Disciples Ministry Center, Inc. shall be managed by the Board of Directors. The Board of Directors shall consist of not less than three (3) and the numbers of Directors may be increase from time to time by law duly adopted pursuant to the law of this corporation, but never be less than three. Directors shall be elected or removed in accordance with the procedure provided in the Bylaws.

The office of Disciples Ministry Center, Inc. shall be a PASTOR, a SECRETARY, and a TREASURER. These officers shall be elected and shall hold office in the manner provided in by its Bylaws.

ARTICLE V MAILING ADDRESS

The mailing address of DISCIPLES MINISTRY CENTER, INC shall be 13840 72ND CT. N. WEST PALM BEACH, FL 33412.

ARTICLE VI INITIAL REGISTERED, OFFICE, ADDRESS, AND REGISTERED AGENT.

The principal office of DISCIPLES MINISTRY CENTER, INC. shall be the address of the registered agent of DISCIPLES MINISTRY CENTER, INC., whose name and address is:

The initial registered agent, upon accepting this designation, agree to comply with the provide of section 617.0505 Florida Statutes as amended from time to time which respect to keeping the office open for service of process.

ARTICLE VII

INITIAL BOARD OF DIRECTORS

The Initial Board of Directors shall consist of three (3) members. The numbers of Directors may be increased from time to time by law duly adopted pursuant to the law of DISCIPLES MINISTRY CENTER, INC., but never be less than three.

ARTICLE VIII

The names and Street addresses of the officers and directors who are to manage all of the affairs of DISCIPLES MINISTRY CENTER, INC., until the first annual meeting are:

ARTICLE IX

CORPORATE POWERS

In addition to all other corporate powers provided by law and in furtherance of the objectives described in Art. III, but not in limitation thereof, DISCIPLES MINISTRY CENTER, INC. shall have the power to:

1. Have succession by its corporate name for the period set forth in its Articles of Incorporation;
2. Sue and be sued and appear and defend in all actions and proceedings in its corporate name to the same extent as a natural person;
3. Elect and appoint such officers and agents as its affairs shall require and allow them reasonable compensation;
4. Adopt, change, amend and repeal bylaws, not consistent with law or its articles of incorporation; and the exercise of its corporate powers;
5. Conduct its affairs, carry out on its operations, and have offices and exercise the power granted by Florida law in any state, territory, district or possession of the United States or any foreign country;
6. Purchase, take, receive, lease, take by gift, devise or bequest, or otherwise acquire, own, hold, improve, otherwise deal in and with real or personal property, or any interest therein, wherever situated;
7. Acquire, enjoy, utilize and dispose of patents, copyrights and trademarks and any licenses and other rights or interests thereunder or therein;
8. Sell, convey, mortgage, pledge, exchange, transfer or otherwise dispose of all or any part of its property and assets, lend, subscribe for, or otherwise acquire, receive, employ,

shares and other interests in, or obligation of, other domestic or foreign corporations, whether for profit or not for profit, associations, partnerships or individuals, or direct or indirect obligations of the United States, or any government, state, territory, or of any instrumentality thereof;

9. Lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security for the payments of funds so loaned or invested;
10. Make donations for the public, or for religious, charitable, scientific, educational or other similar purposes;
11. Have and exercise all powers necessary or convenient to effect any or all of the purposes for which the Corporation is organized; and
12. Merge and consolidate with other not for profit corporations, domestic or foreign, provided that the surviving corporation is not for profit corporation.

ARTICLE X

DISSOLUTION

Upon the dissolution of DISCIPLES MINISTRY CENTER, INC., assets shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code or corresponding section of any future federal tax code, or shall be distributed to faith like churches that keep God's commandments such as SDA churches, the remaining church of Posterity, and to the federal government or to a state or local government for public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
