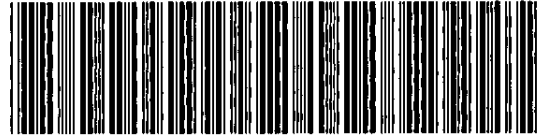

Article Three - This corporation is organized exclusively for educational purposes within the meaning of Section 501©(3) of the Internal Revenue Code. Such purposes in but are not limited to:

Franchise Sports mentors' students to assist them in developing successful careers in the journalism industry through the support of a student-led television program and media website. Under the direction and guidance of Franchise Sports program directors, Franchise Sports student members produce a local sports television show program and distribute content on our website.

Franchise Sports' mission is to mentor, coach and support students in widening their knowledge in those areas that relate to as responsible and ethical broadcast journalism reporting.

Franchise Sports plans to keep the Tallahassee community and the broader alumni community of Tallahassee College and universities informed and serve as an independent means of journalistic, artistic, cultural, and scholarly expression that provides

access to professional skill development and provides students with professional work experience.

Statement of Lawful Purpose - The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the laws of State.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the Statement of Purpose hereof. The property of this corporation is irrevocably dedicated to Franchise Sports 501(c)(3) exempt purpose(s) and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.
