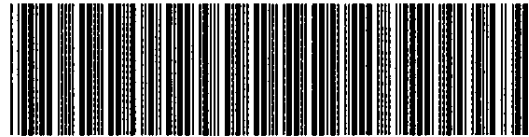

We the undersigned, hereby associate ourselves together for the purpose of forming a Corporation not for profit under Chapter 617, r the Laws of the State of Florida, and in accordance with the following Articles of Incorporation.

I

The names of the Corporation shall be:
HILLSBOROUGH COUNTY MASTERS AND WARDENS ASSOCIATION, INC.
and its principal place of business shall be 3602 West Euclid Avenue Tampa, Hillsborough County, Florida, with the right to change and move said principal place of business within or without the State of Florida as the Board of Directors may from time to time deem proper.

The duration of this Corporation is perpetual. The corporate existence of this corporation shall commence on the date these Articles of Incorporation are executed.


VIII

The undersigned hereby make, subscribe, acknowledge and file these Articles of Incorporation this 24 day of May, 2013.




