ARTICLE OF INCORPORATION OF A
NONPROFIT RELIGIOUS CORPORATION

"GUAN YIN MONASTERY, INC. – NI VIEN QUAN AM"

ARTICLE I: NAME

The name of the corporation shall be "GUAN YIN MONASTERY, INC. – NI VIEN QUAN AM."

ARTICLE II: PRINCIPAL OFFICE

The principal office and mailing address of the corporation shall be 12741 SW 187th Terrace, Miami, Florida 33177.

ARTICLE III: PURPOSE

The purpose of the corporation is to engage in the following business activities:

1. To promote the Buddhist centuries-old tenets of Global peace and understanding;
2. To promote observance and practice of the teachings of the Buddha among the members;
3. To promote the study of Buddhism and related cultural programs in order to improve morality so as to achieve peace, harmony and happiness for all beings;
4. To organize and support activities in the field of social, educational, cultural, charitable and other humanitarian services;

8. The property of this corporation is irrevocably dedicated to religious purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person.

Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable, educational and/or religious purposes and which has established its tax-exempt status under Internal Revenue Code section 501(c)(3).
