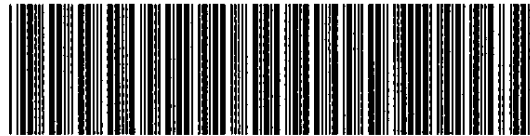

**ARTICLES OF INCORPORATION**

I, **THE UNDERSIGNED**, do hereby execute these Articles of Incorporation for the purposes of forming and becoming a not-for-profit corporation under the Florida Not-for-Profit Corporation Act, and do hereby certify that I have become such a corporation under and pursuant to the following Articles of Incorporation.

**ARTICLE I - NAME**

The name of this corporation is Space Coast Human Resource Association of Brevard, Inc.

**ARTICLE II - ADDRESS**

The principal place of business address is 26 Grandview Boulevard, Cocoa, FL 32922.

The mailing address of the corporation is P.O. Box 541590, Merritt Island, FL 32954.

**ARTICLE III - PURPOSE**

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for

services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or corporation, as said Court shall determine, which are organized and operated exclusively for such purposes.

#### **ARTICLE IV - APPOINTMENT OF DIRECTORS**

The Directors of the corporation shall be elected or appointed pursuant to the Bylaws.

**ARTICLE V - INITIAL BOARD OF DIRECTORS**

The Board of Directors of the corporation shall consist of at least three (3) members.
