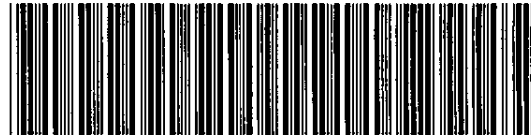

**AMENDED ARTICLES OF INCORPORATION
OF
GLOBAL LIONS MINISTRIES, INC.**

N 13000005308

The undersigned, acting as incorporator of a corporation under the Nonprofit Corporation Act of the State of Florida, adopt the following articles of incorporation for such corporation:

Article 1.

The name of the corporation is Global Lions Ministries, Inc.

Article 2.

The principal mailing address of the corporation is
356 N.E. Double Run Road
Lake City, Florida 32055

Article 3.

The street address of the registered office is
356 N.E. Double Run Road
Lake City, Florida 32055
The registered agent at such address is
Kerceus Andre'

Article 4.

The territory in which the operations of the Corporation is principally to be conducted is The United States of America and its territories and possessions, but the operations of the Corporation may not just be limited to such territory.

Article 5.

The mission of Global Lions Ministries, Inc. is to promote healthy lifestyles choices to address social, educational, and health problems of young people of Columbia County, Florida.

Article 6.

The qualifications for directors and the manner of their admissions shall be regulated and stated in the by-laws

Article 7.

Global Lions Ministries, Inc., is organized exclusively for religious, charitable, educational, and/or scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) or the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article 8.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 7 hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, corresponding section of the future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Article 9.

Upon the dissolution of the corporation assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article 10.

No director shall have any personal liability to the corporation or other directors of the corporation, for monetary damages for breach of duty of care or other duty as a director, by reason of any act or omission occurring subsequent to the date when this provision becomes effective, except that this provision shall not eliminate or limit the liability of a director for (a) any appropriation, in the violation of his/her duties, of any business opportunity of the corporation; (b) acts or omissions which intentional misconduct or a knowing violation of the law; (c) liabilities of a director imposed by Section 14-3-860 through 14-3-864 of the Georgia Non-Profit Corporation Code; or (d) any transaction from which the director derives an improper personal benefit.

Article 11.

The corporation will not have members.

Article 12.

The initial board of directors shall consist of at least seven (7) members who need not be residents of the State of Florida.
